# **ANNUAL REPORT**

# APRIL1, 2015 – MARCH 31, 2016

The Catholic Health Association of New Brunswick has been very active over the past year in support of Catholic healthcare within our jurisdiction. There were many issues placed before the Board and Committees during the year the most pressing again being the Supreme Court decision regarding Physician Assisted Death.

## **RELIGIOUS AND SPIRITUAL CARE**

As in the past, the Association continued the development of strong relations with the Provincial Government. The province continues to fund the provincial committee in the amount of \$50,000.00 per year. The Committee, originally founded by the Catholic Health Association of New Brunswick, continues to work under the name of the New Brunswick Spiritual Health Network . The Annual Report of this group is attached. Rick Benson of Saint Joseph's Hospital in Saint John is the Chairperson of this Network.

There has been no further development regarding the request made to the provincial government to work with the Association to develop a statue and/or sculpture recognizing the contribution of the Sisters of the province in the areas of health, education and social service. This issue will continue to placed on the agenda of future meetings. A new committee was appointed by the CHANB Board to work on this project, however, the committee has not met to date.

#### **EDUCATION**

The Education Committee under the chairperson, Vicky Knight, met during the year as required mainly to plan for this conference. Other issues discussed were the scholarship program and the Values Integration Assessment program. It is noted that eight scholarships in honor of the Sisters are awarded each year in the amount of \$1,000.00 each. The Scholarships are offered to students who have completed their first year of studies in a health related field and renewable for four years. The scholarships are equally shared between Anglophone and Francophone students. There is a selection committee in place for each group to award these scholarships, it is no easy task as the response is excellent. The Anglophone scholarship in 2015 was

awarded to Nicole Johnston of Saint John, and the Francophone scholarship was awarded to Olivier Savoie of Beresford.

The Catholic Leadership program continues to operate at capacity. The English program will be offered in 2016-17 and has a waiting list.

Support for the CHAC Annual Conference was again evident this year with a good attendance.

# **STRATEGIC PLANNING**

The strategic plan developed in 2014 continues to be rolled out. The Board of Directors developed a number of themes for a three to five year period. The theme presently being developed is communication. Over the coming months you can look forward to a greater awareness of the Association through social media, etc.

During the past year, the By-Laws review committee met on several occasions to completely revise the CHANB By-Laws. The final proposed By-Laws were recommended to the Board for their recommendation and approval to the General Assembly in September 2016.

# ADVOCACY

There were several areas which required involvement of the CHANB. The first being the Supreme Court Decision on Physician Assisted Dying. The CHAB worked hand in hand with Catholic Health International and the Catholic Health Alliance of Canada. Meetings were held nationally through those organizations with the Canadian Conference of Bishops and other provincial organizations. Locally, meetings were held with the four Bishops in New Brunswick to assist them in understanding the plan being developed by the catholic health care organizations in Canada. We make every effort to keep the Bishops informed and communicate with all our facilities regarding policy development, etc. CHANB prepared a statement in harmony with CHI and the other organizations and distributed it to all our facilities including the two Region Health Authorities.

The provincial government over the past few months made a decision to place the debts and assets of the provincial nursing homes on the books of the province. The CHANB in partnership with Catholic Health International and the New Brunswick Association of Nursing Homes immediately opposed this decision. While this matter has not been finalized because it is still in the courts, we have been assured by the minister directly that there is no intention to acquire the assets. We will continue to monitor this situation.

Their remains the issue of a recommendation by the Regional Health Authorities to the Provincial Government to "take over" the operation of the nursing homes and

place them under the health authorities. This is still a hot issue and we will continue to monitor this situation as well.

Recommendations for appointments to the Horizon Health Network and Vitalité Network were made to the Minister of Health as per the *Agreement*.

Concern was expressed during the year regarding restructuring taking place in Vitalité Health Network which, at first, conflicted with the terms of the *Agreement*. We have been assured that Vitalité supports and will honor the *Agreement*.

The President and Executive Director attended the Provincial Associations meeting in Toronto in December. This annual meeting provides an opportunity to discuss items of mutual concern across the country.

## FINANCIAL

The Association continues to operate in a prudent fiscal manner producing a small surplus each year. The Association works in partnership with Catholic Health International to fund many educational opportunities provided to our membership.


